## 1. ELIGIBILITY:

No purchase necessary to enter or win. The Sweepstakes is open to lawful residents of Canada (except Quebec) who have reached the age of majority in their province/territory of residence. Officers, directors, representatives and employees of Mortgage Alliance ("**Sponsors**"), their respective parents, affiliates, subsidiaries, brokers, agents, franchisees, their respective advertising, promotional, publicity, production or judging agencies, and persons domiciled with or the immediate family members of any of the foregoing are not eligible to enter.

## 2. SWEEPSTAKES PERIOD:

The Sweepstakes commences January 1, 2025 and closes at 11:59:59 PM Eastern Time on December 31, 2025 ("Sweepstakes Period").

## 3. HOW TO ENTER:

There are two (2) ways to enter the Sweepstakes. During the Sweepstakes Period, participate by:

- a) Submitting a bona fide mortgage application through a Mortgage Alliance Broker, Agent or Franchisee in good standing with Mortgage Alliance. Provided your mortgage application has been approved by all the appropriate parties and creditors, and subsequently funded through Mortgage Alliance during the applicable Drawing Period (see Paragraph 6 below) of the Sweepstakes Period ("Qualifying Mortgage"), your name will be automatically entered. If you complete this process through the prequalification tool online at yourmortgagemarket.com, then you obtain one additional entry chance.
- Obtaining one (1) unique entry code, by mailing an original written
- b) submission (minimum of 500 words) of how winning the Prize would help you buy your dream house and if you would consult for doing so a Mortgage Alliance Broker, Agent or Franchisee, along with providing your name, province/territory, age, and mail address (the "No Purchase Request") to 200 – 2005 Sheppard Ave. E, Toronto, ON M2J 5B4. Submission must be readable, original in concept and execution, and personally created by entrant. Within five (5) business days of receipt of a No Purchase Request, the Sponsors will mail you a unique entry code with instructions to use for entering the Sweepstakes. Maximum one (1) No Purchase Request per household during the Sweepstakes Period. All No Purchase Request must be received by 11:59:59 PM Eastern Time on December 31, 2025

All entries become the sole property of the Sponsors and none will be returned for any reason.

#### 4. LIMIT:

Limit of one entry per Qualifying Mortgage or household during the Sweepstakes Period.

## 5. THE PRIZE:

There is one (1) grand prize (the "Prize") to be won for each 2025 quarter of the Sweepstakes Period, consisting of the value of your Qualifying Mortgage payments in principal and interests up to a maximum amount of \$25,000, based on your first monthly mortgage payment (up to a monthly payment of \$2,083.33 in principal and interests) x 12 months. If your Qualifying Mortgage installments are not made on a monthly basis, then the reference will be the total of payments made during your first full month of your Qualifying Mortgage.

For example, for a Qualifying Mortgage, if your first monthly mortgage payment totals \$1,666.67 in principal and interest (taxes, fees and other charges excluded), then the Prize will be \$20,000 (i.e. \$1,666.67 x 12). If your first monthly mortgage payment totals \$2,500.00, then the Prize will be \$25,000 (i.e. \$2083.33 x 12).

In the event that the Qualifying Mortgage selected has more than one applicant, the prize will be divided evenly among the qualifying applicants. If you do not have a Qualifying Mortgage, the Prize is \$25,000. The Prize will be awarded in the form of a cheque payable to the winner(s).

## 6. THE DRAW:

- d) Fourth Draw: The fourth and last draw will be made on February 1, 2025 for all eligible entries received between October 1, 2025 and 11:59:59 PM Eastern Time December 31, 2025.

The potential winner will be contacted by phone or mail. The Prize will be confirmed within two weeks of contact from the potential winner. In order to win, the selected entrant or, in the event there is more than one mortgagor associated with the selected Qualifying Mortgage, one of the mortgagors associated with the selected Qualifying Mortgage who has been designated by all of the mortgagors, must first correctly answer without any electronic, mechanical or other assistance a time limited mathematical skill testing question to be administered by telephone at a pre-arranged, mutually convenient time.

## 7. PRIZE CLAIM CONDITIONS:

Sponsors reserves the right to terminate, suspend or modify this Sweepstakes, in whole or in part, for one quarter only or more, at any time and without notice or obligation if, in Sponsors sole opinion, any factor interferes with its proper conduct as contemplated by these Official Rules.
